of the public (closed) contest among the participants of

"Login Casino Awards"

PRELIMINARY STATEMENT

This Statute (hereinafter referred to as "Statute") in compliance with chapter 57 of the Civil Code of the Russian Federation identifies the terms and conditions of the Public Contest "Login Casino Awards" among those operating in the field of entertainment and gambling business (provision of services on organizing gambling activities, in the esports industry, or related services), in the field of services delivery to organizers in the sphere of entertainment and gambling business, as well as in the industry media and software developers.

"Login Casino Awards" is a professional contest in the field of entertainment and gambling business.

1. TERMS

In the part of the Statute below the following terms are used:

1.1.ORGANIZER – the organizer of the contest is SMileS LLC (hereinafter referred to as SMileS or "Organizer")

1.2 CONTEST – "Login Casino Awards" contest held by the Organizer in compliance with this Statute and the legislation of Russian Federation.

The contest "Login Casino Awards" in accordance with p. 3, art. 1057 of the Civil Code of the Russian Federation is of closed format.

The contest is held online on the website: https://logincasino.com/ (hereinafter – Website).

1.3. CONTESTANT (or PARTICIPANT) – a company, operating legally in the Russian Federation and/or abroad, whose activity is connected with the topic of the nominations outlined in p.6 of this Statute, which received Organizer's invitation to participate and accepted all the terms and conditions of this Statute and fulfilled all the formal actions that in accordance with this Statute are considered sufficient to confirm their participation in this Contest.

Only those nominees are allowed to take part in the Contest who operate legally strictly in accordance with the regulations of the legislation of Russian Federation and/or in accordance with the regulations of those countries (jurisdictions) where the foreign participants of the Contest operate.

1.4.WINNER – Contestant recognized as the best in 2020 basing on the criteria applied to this Contest in one or several nominations of this Contest.

2. AIMS OF THE CONTEST

2.1. The aims of this Contest are:

- 2.1.1. identification and rewarding of those individuals who, according to the experts and consumers of the services of the betting industry, esports or other related services, are the best in the nominations of 2020 announced by this Contest;
- 2.1.2. providing the professional representatives of the betting industry, eSports or other related services with the information about the current and new projects, solutions and technologies, promoting the quality of the services provided.

3. CONTEST TIME FRAME

- 3.1. The timing for application forms reception, in accordance with p. 5 of this Statute: from 12 p.m. on October "12", 2020 to 11.59 p.m. on October "26", 2020.
- 3.2. Online voting: from 12 p.m. on October "27", 2020 to 12 p.m. on December "7", 2020.
- 3.3. Hiding of voting: from 12 p.m. on November "23", 2020 to 12 p.m. on December "7", 2020
- 3.4. Announcement and rewarding of Winners: 12 p.m. (MSK) on December "16", 2020.

4. INFORMATION ABOUT THE COURSE OF THE CONTEST AND ITS RESULTS

- 4.1. Information about the terms and conditions of this Contest, nominations, Contestants, voting conditions, Winners and other information relating to the Contest is placed by the Organizer on the website: https://logincasino.com/
- 4.2. At the discretion of the Contest Organizer, the information about Contestants and Winners of the Contest can be also placed on other websites of the Organizer, in the media, as well as in other resources providing information about gambling business industry.
- 4.3. Information about the Winners of the Contest is announced publicly at the award ceremony on the date specified in p. 3.4 of this Statute.
- 4.4. All votes of participants go through moderation, invalid ones are removed and not counted. A vote is considered to be the email address under which the user has registered to vote for the participant in the contest.

Moderation is considered to be the process of checking email for its existence and validity. A contestant for whom invalid votes are cast will be disqualified for repeated regular violations.

5. CONDITIONS OF PARTICIPATION FOR THE CONTEST

- 5.1. Taking part in the Contest is permitted for both Russian and foreign companies operating in the spheres according to the nominations, outlined in paragraph 6 of this Statute, which received a corresponding proposal from the Organizer and accepted this proposal from the Organizer.
- 5.2. The Organizer chooses and defines the scope of potential nominees, whom (to each one individually) sends an invitation letter to become the Contestant (Participant) of this Contest. The letter of proposal can be sent by the Organizer both in paper and electronic form (as well as in two ways simultaneously) at the discretion of the Organizer.
- 5.3. The company that received the invitation letter from the Organizer and decided to participate in the Contest (decided to be nominated) must send to the Organizer of the Contest the filled-in application form of the Contestant, which is attached to the Organizer's invitation letter.

The Organizer examines the received application form and in case it is completed appropriately and to the full (absence of incorrect information, absence of blank spaces instead of answers to the questions of the application form) adds the applicant, whose application form was received in response to the invitation letter, to the list of Participants (Contestants) of the Contest and places

(within 5 working days) all the relevant information about the Contestant on the website of the Organizer https://logincasino.com/ .

The receipt of the application form, indicated in this paragraph, by the Organizer of the Contest means a complete and unconditional acceptance of the Contestant in accordance with this Statute.

5.4. The Organizer reserves the right to reject any individual that declared his/her participation in this Contest (i.e. willingness to take part in the Contest under the conditions identified by this Statute).

The Organizer can exercise the right to reject the application form in the following cases:

- inaccurate information about the potential participant in the Contestant's application form;
- incomplete information about the potential participant in the Contestant's application form;
- non-compliance of the activity or the information about the potential participant with the requirements of the legislation of the Russian Federation and/or requirements of the laws applicable to the activity of the foreign potential nominee of the Contest.
- expiry of the period outlined in p. 3.1 of this Statute.

The Organizer can exercise the right to disqualify a Participant from competing:

- for insulting and violation of the rights of other participants of the Contest;
- for the incitement of inter-ethnic discord;
- for placing materials of erotic, pornographic or any other nature that is prohibited by the legislation of the Russian Federation;
- for any other unlawful acts from the perspective of legislation of the Russian Federation
- 5.5. Organizer has the right for promotional purposes (advertisement of the events organized and held by the Organizer) to use references to the Participants (Contestants) of the Contest, place on the website of the event (or on other resources of the Organizer and the Organizer's counterparties for promotional purposes) images of the trademarks/service marks of the participants (Contestants) of the Contest, otherwise to refer to the Contestant as a Participant (Contestant) of this Contest.
- 5.6. The nominee who refused to further take part in the Contest (Participant in order to identify the party of the present public contract) does not have the right to demand from the Organizer of the Contest to delete the information about oneself (Participant) from other (except for the Organizer's Internet sites) resources, in case these resources contain information more than about the Participant that refused (catalogues, any printed materials, etc.).

6. NOMINATIONS OF THE CONTEST. ASSESSMENT CRITERIA. VOTING

- 6.2. In accordance with the nominations and assessment criteria, Contestants operating on the territory of the Russian Federation, are assessed for their achievements and efforts in the activity carried out on the territory of the Russian Federation, while foreign participants of the betting market are assessed for their achievements and efforts in the activity carried out within their respective jurisdictions.
- 6.3. Winner in each Nomination is chosen via electronic voting (hereinafter referred to as online voting).
- 6.4. Only those Website users who registered according to the rules of the Website are allowed to participate in online voting on the Website.
- 6.5. The users who registered on the Website are voting of their own choice for Contestants in each Nomination. Visitors of the Website https://logincasino.com are allowed to vote for one nominee in each of the permissible (accessible for voting) categories of the nominations.

7. WINNERS DETERMINATION PROCEDURE

7.1. The Contest Winners are identified in each nomination basing on the criteria listed in p.6 of this Statute.

- 7.2. The decision to recognize the Contestant as the Winner of the Contest is made by the Contest Organizer basing on the outcome of the voting in accordance with the assessment criteria for the participants (Contestants) of the Contest and basing on the criteria listed in p.6 of this Statute.
- 7.3. In each nomination only one Contestant is recognized as the Winner.
- 7.4. In case there is only one nominee (Contestant) in a particular category of a particular nomination, the Contestant still has a chance to become the Winner on condition that this Contestant receives at least one vote.
- 7.5. The Contest Winners will be publicly announced on December 16, 2020 by the Contest Organizer during the live webcast of the award ceremony "Login Casino Awards". After the broadcast, the results of the online voting will be published on the website: https://logincasino.com.
- 7.6. Winners in each nomination will receive electronic certificates.

8. FINAL PROVISIONS

- 8.1. The Contest is held in accordance with the legislation of Russian Federation and/or regulations of the foreign law that regulate the activity of foreign participants (Contestants) of the Contest.
- 8.2. The Organizer reserves the right to make amendments to this Statute (Public offer).

Notification regarding the changing conditions or cancellation of the Contest is carried out in accordance with the procedure identified for the contest announcement.

- 8.3. The application submission by the Contestant in accordance with the procedure identified in paragraph 5 of this Statute means the Contestant's unconditional agreement to all the terms and conditions of this Statute.
- 8.4. In the issues that are not identified in this Statute, both Organizer and Contestants act according to the legislation of Russian Federation.
- 8.5. Any dispute or disagreement arising in connection with participation in the Contest should be settled by negotiation. Compliance with the pre-trial complaints procedure is not obligatory and is applied by choice of the parties. Disputable issues which are not settled by negotiation shall be settled by the court at the location of Contest Organizer and in accordance with procedural or any other applicable legislation of the Russian Federation.
